For and in consideration of the use of the swimming pool facilities and the services rendered by INFANT SWIMMING RESOURCE BY CHRISTI JANECEK AND/OR INFANT SWIM WITH CHRISTI LLC, including swimming lessons, water safety instruction, use of the bathroom and changing room and the appliances used in conjunction therewith, we release, remise and do hereby forever discharge for ourselves and our minor child(ren), our heirs, assigns, executors and administrators from any and all manner of action, suits, debts, covenants, contracts, controversies, agreements, promises, claims and demands whatsoever, in law or in equity, which against INFANT SWIMMING RESOURCE BY CHRISTI JANECEK AND/OR INFANT SWIM WITH CHRISTI LLC,, we ever had, now have or which we are or our heirs, executors and administrators hereafter, can, shall, or may have for or by any accident or injury which occur to our minor child(ren) while participating in any swimming lessons, water safety instruction or prior to any swimming lesson or water safety instruction or after any swimming lesson or water safety instruction while on the premises of 2720 Scenic Hills Drive, Bedford, TX 76021.

We do hereby understand and agree to be responsible for our minor child(ren) while on the premises of 2720 Scenic Hills Drive, Bedford, TX 76021 and the business of INFANT SWIMMING RESOURCE BY CHRISTI JANECEK AND/OR INFANT SWIM WITH CHRISTI LLC, and hold Christi Janecek harmless for any injury suffered by our minor child(ren) or us while thereon. We do understand and agree that while our minor child(ren) is on said premises, except for the time the minor child(ren) is physically participating in any swimming lesson, water safety instruction, or other related activities being conducted by the instructor of INFANT SWIMMING RESOURCE BY CHRISTI JANECEK AND/OR INFANT SWIM WITH CHRISTI LLC, that we will supervise the actions and activities of our minor child(ren), will keep our minor child(ren) off and away from any play facilities, including swing sets, and/or children's play toys that may be on the premises and that we take all efforts reasonably necessary to keep control of our minor child(ren) so as to prevent injury to our awaiting child(ren) for the swimming lessons or water safety instruction. We have inspected the premises and know the risk and dangers involved in such activities, in that unanticipated and unexpected dangers may arise during such activities, and we assume all risks of injuries of our child(ren), our person, and our property that may be sustained in connection with the stated and associated activities in and about the premises.

It is further agreed and understood that we as parents of our child(ren) have total, full and absolute responsibility for reading and abiding by any and all of the information, guidelines and regulations given to us by the instructor of INFANT SWIMMING RESOURCE BY CHRISTI JANECEK AND/OR INFANT SWIM WITH CHRISTI LLC, as to insure that our minor child(ren) will receive the safest, most effective swim lesson, water safety instruction possible. We do understand and agree that by not following the specific instructions of the instructor of INFANT SWIMMING RESOURCE BY CHRISTI JANECEK AND/OR INFANT SWIM WITH CHRISTI LLC,, an accident or injury may result for which we hold CHRISTI JANECEK and said premises for any accident or injury suffered by our minor child(ren) or by us not responsible. It is further agreed and

understood that if our child(ren) is withdrawn from INFANT SWIMMING RESOURCE BY CHRISTI JANECEK AND/OR INFANT SWIM WITH CHRISTI LLC, prior to completion, which is determined by the instructor, that INFANT SWIMMING RESOURCE AND CHRISTI JANECEK make no guarantees whatsoever as to our child(ren)'s ability to swim or survive any supervised or unsupervised aquatic activity or accident. We as parents of our child(ren) have total, full and absolute responsibility for anything which may occur before our child(ren) is handed to the INFANT SWIMMING RESOURCE instructor, and anything that may occur after the INFANT SWIMMING RESOURCE instructor hands our child(ren) back to us from the water and the lesson. Further, we hereby warrant that we understand that INFANT SWIMMING RESOURCE makes to guarantees whatsoever as to any child's ability to swim or survive any unsupervised aquatic accident. Finally, we understand that even when our child(ren) completes INFANT SWIMMING RESOURCE lessons, water safety instruction, we are absolutely and totally responsible for the uninterrupted **constant supervision** of our child(ren) anytime he or she is in or around the water.
